EDUCATION. WE PROVIDE ENVIRONMENTAL EDUCATION TO PEOPLE OF ALL AGES. OUR EDUCATION PROGRAMS FOSTER SCIENTIFIC PROFICIENCY AND CRITICAL THINKING AND PROMOTE A SENSE OF CURIOSITY AND WONDER IN NATURE. DURING 2018, WE HAD 669 K-12 STUDENT VISITS, AND HELD 42 PUBLIC PROGRAMS THAT WERE ATTENDED BY 450 PEOPLE. WE ALSO HOSTED 12 COLLEGE INTERNS WHO SPENT A TOTAL OF 729 HOURS WORKING ON THE FIELD STATION.

RESEARCH. WE CARRY OUT RESEARCH TO INCREASE KNOWLEDGE OF THE ECOLOGY OF THE FIELD STATION, UNDERSTANDING HOW NATIVE PLANTS AND ANIMALS ARE AFFECTED BY RESTORATION, AND DETERMINING HOW TO CONSERVE SPECIES THAT ARE RARE OR DECLINING. IN 2018, COLLEGE INTERNS HELPED US MAP INVASIVE SPECIES OF PLANTS AROUND THE FIELD STATION. OUR GOAL IS TO UNDERSTAND HOW HISTORICAL LAND USE AFFECTS THE CURRENT DISTRIBUTION OF INVASIVE SPECIES AND HOW TO DIRECT OUR REMOVAL EFFORTS. WE ALSO CONDUCTED SEVERAL BIRD, BUTTERFLY, BEE, AND PLANT SURVEYS. THE 2018 BIODIVERSITY SURVEYS WILL PROVIDE CLEAR BASELINE INFORMATION FOR SEVERAL GROUPS OF ANIMALS AND PLANTS SO THAT WE WILL BE ABLE TO MEASURE THE EFFECTIVENESS OF OUR RESTORATION ACTIONS.

RESTORATION. WE ARE PROTECTING ALL SPECIES OF NATIVE PLANTS AND ANIMALS THAT ARE FOUND ON OUR 890-ACRE FIELD STATION IN WARRENTON, VIRGINIA. WE AIM TO BOLSTER THE POPULATIONS OF SPECIES THAT ARE IN DECLINE. DURING 2018, WE MOVED CATTLE OFF PART OF OUR PASTURE AND ESTABLISHED A RIPARIAN BUFFER OF TREES AND SHRUBS ON THE FORMER PASTURE WITH THE HELP OF 18 VOLUNTEERS WHO SPENT 80 HOURS ON THE PROJECT. WE INSTALLED A NEW NATIVE PLANT GARDEN. WE BUSH HOGGED AND REMOVED AUTUMN OLIVE FROM OUR SHRUB FIELDS, AND DISCED FIRE BREAKS IN PREPARATION FOR PRESCRIBED BURNS.
