**EDUCATION. WE TEACH PEOPLE ABOUT THE NATURAL HISTORY, ECOLOGY AND EVOLUTION OF NATIVE PLANTS AND ANIMALS. DURING 2020, 631 STUDENTS ATTENDED 31 SCHOOL PROGRAMS, 23 FAMILY HIKES, AND 4 WEEKS OF SUMMER CAMP; 683 ADULTS ATTENDED 58 WALKS AND TALKS; AND 13 INTERNS LEARNED HOW TO DO SCIENCE AND WORK AT AN ENVIRONMENTAL NONPROFIT.**

**RESTORATION. WE PROMOTE NATIVE SPECIES, ESPECIALLY THOSE THAT ARE DECLINING, AND RESTORE, AS MUCH AS POSSIBLE, THE COMMUNITY OF PLANTS AND ANIMALS THAT LIVED HERE BEFORE EUROPEAN SETTLEMENT. DURING 2020, WE CLEARED 21 ACRES OF AUTUMN OLIVE SAPLINGS IN OUR SHRUBLANDS TO ALLOW NATIVE PLANTS TO RECOLONIZE; BURNED 15 ACRES TO PREVENT SUCCESSION, CONTROL EXOTIC SPECIES AND PROMOTE NATIVE PLANTS; AND MULCHED 11 ACRES OF SHRUBLANDS TO PREVENT SUCCESSION TO FOREST. WE PROPAGATED OVER 2,000 SEEDLINGS FROM SEEDS OF 79 SPECIES OF NATIVE PLANTS, WHICH WE PLANTED IN 2 NEW GARDENS OF EXCLUSIVELY LOCAL-ECOTYPE SEEDLINGS AND DISTRIBUTED AT 2 PLANT SALES. AND WE VISITED 12 LOCAL LANDOWNERS TO GIVE ADVICE ON MANAGING THEIR PROPERTIES FOR THE BENEFIT OF NATIVE BIODIVERSITY.**
