DURING 2021, 1,402 PRE-K-12 STUDENTS AND 698 ADULTS ATTENDED EDUCATION PROGRAMS. PARTICIPANTS IN OUR PROGRAMS GET TO SPEND TIME OUTSIDE IN NATURE. WE ALSO GIVE PEOPLE YOUNG AND OLD THE OPPORTUNITY TO PARTICIPATE IN REAL SCIENTIFIC RESEARCH AND ENCOURAGE THEM TO ASK THEIR OWN QUESTIONS ABOUT THE WAY NATURE WORKS.
