EDUCATION. WE TEACH PEOPLE ABOUT THE NATURAL HISTORY, ECOLOGY AND EVOLUTION OF NATIVE PLANTS AND ANIMALS. DURING 2022, 1,988 PRE-K-12 STUDENTS AND 1,434 ADULTS ATTENDED MORE THAN 170 EDUCATION PROGRAMS. FROM LEARNING HOW TO IDENTIFY LICHENS TO PRACTICING COLLECTING NATIVE SEEDS, EVERY PROGRAM IS DIFFERENT. THE UNIFYING THEMES ARE: ENJOYMENT OF NATURE; CURIOSITY ABOUT THE NATURAL WORLD; AND TAKING CARE OF NATIVE PLANTS AND ANIMALS.

RESTORATION. WE PROMOTE NATIVE SPECIES, ESPECIALLY THOSE THAT ARE DECLINING, AND RESTORE, AS MUCH AS POSSIBLE, THE COMMUNITY OF PLANTS AND ANIMALS THAT LIVED HERE BEFORE EUROPEAN SETTLEMENT. DURING 2021, WE LAUNCHED A NATIVE SEED PILOT PROJECT AND HIRED A PROJECT COORDINATOR TO LEAD THE PROJECT, INCLUDING SEED COLLECTION, PLANT PROPAGATION, RECRUITMENT OF FARMERS, AND COORDINATION WITH PARTNERS. IN THE FALL, WE WORKED WITH VOLUNTEERS AND PARTNERS TO COLLECT SEEDS FROM OVER 100 SITES ACROSS VIRGINIA.

WE DO SCIENTIFIC RESEARCH IN ORDER TO DETERMINE THE BEST METHODS FOR CONSERVING DECLINING PLANTS AND ANIMALS, TO UNDERSTAND THE EFFECTS OF OUR AND OTHERS' RESTORATION WORK ON NATIVE BIODIVERSITY, TO LEARN ABOUT THE ECOLOGY OF THE NORTHERN VIRGINIA PIEDMONT, AND TO TEACH STUDENTS AND OUR COMMUNITY HOW TO DO SCIENCE. IN 2022, WE CONTINUED OUR RESEARCH ON WHY AMERICAN KESTRELS ARE DECLINING. WE ALSO LAUNCHED A MULTI-YEAR, COLLABORATIVE RESEARCH PROJECT FOCUSED ON BOX TURTLES.
